Clinton Public Hospital Foundation Annual Report from the Chair 2019-2020

I am pleased to report that the 2019-2020 fiscal year was another very successful year for the Clinton Public Hospital Foundation, thanks to our very supportive and generous community.

On Sunday, June 23, 2019, Clinton Raceway Inc. hosted their biennial Legends Day at the Clinton Raceway, with proceeds to the Clinton Public Hospital Foundation. The event included an online auction, a silent auction, a 50/50 Raffle and a Pineridge Chicken BBQ Dinner. As one can imagine, a lot of organization, many volunteer hours and community support were required to make this event a success. I am so thankful to everyone who organized and supported this event, including our volunteers, our sponsors, those who donated auction items, the drivers and those who attended the event. Thank you to Clinton Raceway Inc. for being such a wonderful community partner and for hosting this fantastic event. This year's Legends Day raised a net profit of \$55,691 for the accessible tub and shower room on the inpatient unit at Clinton Public Hospital.

As in past years, the Foundation took part in the annual CKNX Health Care Heroes Radiothon, which was held in Wingham on Saturday, October 19, 2019. Our fundraising goal for the event was to raise \$40,000 towards the accessible shower on the inpatient unit. We received generous donations and raised \$28,261 from this event. In conjunction with the Radiothon, the Clinton & District Kinsmen once again hosted their annual breakfast on Saturday, October 19, at the Central Huron Community Complex. We had a record number served and the breakfast was great. The generosity and dedication of the Clinton & District Kinsmen is greatly appreciated! We have participated in the CKNX Health Care Heroes Radiothon since its inception in 2002 and throughout those years we have received donations for an accumulated total of \$542,761.13.

Funds from both Legends Day and the Radiothon, along with an additional \$48,098 from other donations received throughout the fiscal year were transferred to HPHA to cover the full cost of the accessible tub and shower room for the inpatient unit.

In December each year, we launch our annual Christmas Campaign. We send out a general letter giving thanks to our supportive community and sending them Season's Greetings. This year, students at Central Huron Secondary School were able to volunteer time to assist us with the campaign by stuffing the envelopes for us. It takes approximately 90 hours to stuff and sort the mailing, so it is very helpful to have the students' assistance with this and I thank them for doing this. The letters, along with donation forms, were mailed out to our local community on December 2nd, which coincided with Giving Tuesday, as the kick off to the giving season. As in past years, we received many generous donations throughout the holiday season. This year the campaign was very successful and raised a net profit of \$27,297.88, as well as an additional profit of \$3,053.07 from Giving Tuesday.

Throughout the 2019-2020 fiscal-year, we received multiple bequests (\$654,653.69) and many memorial donations (\$29,283.96). We are truly grateful to those who plan ahead to make a financial gift to the Clinton Public Hospital Foundation upon their passing and also to the families who name the Foundation as the charity to receive donations in memory of their loved one.

The Auxiliary to the Clinton Public Hospital were generous in transferring \$18,000 to the Foundation in 2019-2020 to be used for the purchase of several pieces of specified equipment for our hospital. We are truly grateful to have the dedication and support of our Auxiliary.

In addition to our fundraising efforts, the Clinton Public Hospital Foundation Board of Directors and Staff have continued to share the Foundation's various activities on our website and on social media. The Foundation continues to focus on public communication and a social networking presence, as a means to keeping our community and donors informed.

With the financial support of our donors, we were able to transfer a total of \$422,334.40 in the 2019-2020 fiscal year. This transfer of funds supported the following projects and equipment purchases:

- Renovations for and installation of the Digital X-Ray Unit
- Accessible Tub and Shower Room for Inpatient Unit
- Table for Inpatient Lounge (Auxiliary Funded)
- 2 Bariatric Chairs for Inpatient Lounge (Auxiliary Funded)
- Laryngoscope (Auxiliary Funded)
- Nursing Education (RBC Nursing Strategy Grant)

- CPR Training Mannequins (1 adult; 1 infant)
- Refresh of MDRD Project
- PATH Project
- Physician Recruitment

In 2019-2020, the Foundation recorded a total of 483.5 volunteer hours, which included 332.5 hours in director roles and 151 volunteer community hours. Volunteer hours accounted for 28% of the hours contributed to the Foundation, with the other 72% in staffing hours. Volunteers are an enormous asset to the Foundation, for which we can attribute much of our fundraising success, alongside the generous support of our financial donors.

It has been a great year for the Foundation. I would like to thank each director for their hard work and commitment, allowing the Foundation to be successful in meeting our commitments to our hospital. I would also like to thank the CPH Auxiliary, the staff and the community for supporting the Foundation in our mission. On behalf of the Board of Directors, I would like to extend our heartfelt thanks to every individual, business and organization, who has supported the Clinton Public Hospital. We are very fortunate to be a part of such a caring community.

Clinton Public Hospital Foundation Fundraising Annual Report 2019-2020

It is so fabulous to live in a community that continues to support Clinton Public Hospital, both financially and through individuals volunteering their time and talents.

The 2019-2020 fundraising events began with Legends Day, which was hosted by Clinton Raceway on Sunday, June 23, 2019. The event included an online auction, a silent auction, a 50/50 Raffle and a Pineridge Chicken BBQ Dinner. Many volunteer hours were required to make this event a success. It is so wonderful to have the support of our volunteers, sponsors, donors, the harness racing community and those who attended the event. Having Clinton Raceway Inc. as a community partner is fantastic and I truly appreciate their support of the Clinton Public Hospital. This year's Legends Day was a great success and raised a net profit of \$55,691.09 for our hospital.

The Foundation took part in the annual CKNX Health Care Heroes Radiothon again this year, which was held at CKNX on Saturday, October 19, 2019. We set our fundraising project to raise \$40,000 for the inpatient accessible shower room. Through generous donations, we raised \$28,261.08 towards our goal, which was used towards the project, which has been completed and is in use for the patients. As in past years, the Clinton & District Kinsmen hosted their annual breakfast on Saturday, October 19, at the Central Huron Community Complex. The breakfast was delicious and enjoyed by many. The commitment and support of the Clinton & District Kinsmen is truly amazing. The Foundation has participated in the CKNX since its inception in 2002 and over those 15 years, we've received donations for an accumulated total of \$542,761.13 for our hospital.

Various other third-party fundraising efforts took place throughout the year as well, contributing towards the success of our financial goals. The Blyth Legion Ladies Auxiliary donated profits from their Penny Sale in the amount of \$600 to the Foundation. The Huron Pioneer Thresher and Hobby Association donated \$1000 of the proceeds from their annual reunion. The Huron County Wedding Show donated the proceeds from their annual Wedding Show, in the amount of \$1,500. The Thursday Tunes Committee donated \$1000 from their entrance fees, the Clinton Lions Club donated \$6000 from the proceeds of their Chase the Ace fundraiser and Michael's Pharmasave Dreamboats concert raised \$2,000 for the Foundation. In addition to these fundraising events, we received many other donations from individuals, organizations and businesses throughout the year. All donations large or small make a difference to our hospital.

This year's Christmas Campaign was supported by individuals and businesses, from Clinton and surrounding communities. The campaign brought in a net profit of \$27,297.88 from these generous donations. Our Giving Tuesday Campaign, the kick-off to the season of giving, raised \$3,053.07. At such a busy time of year, it is truly wonderful to see that the Christmas Spirit is still alive and well in our community. Words cannot express the appreciation that the Foundation has for the financial support during this wondrous time of year.

The Clinton Public Hospital Auxiliary continues to be a very hard working an amazing group of individuals and we sincerely thank them for their continued support. Each year, the Auxiliary presents the Foundation with a cheque from their fundraising efforts. In April 2019, again they presented us with a wonderful donation in the amount of \$18,000.00, to support various equipment purchases for our hospital.

The Foundation applied for the Royal Canadian Legion Grant this year. This grant provides funding through the process of application, for a specific piece of equipment that is beneficial to patient care. The application submitted was for two items this year, a slit lamp for the emergency department and a tilt-wheelchair, at the recommendation of HPHA. The Legion granted the Foundation \$9,113.00 for the purchase of the slit lamp only. The Foundation is eligible to apply for this funding every two out of three years, and as such is not eligible to apply in 2020. I would like to thank the Royal Canadian Legion for continuing this grant, as a means to fund equipment needed and for their continued support of Clinton Public Hospital.

I am so grateful to be able to volunteer and make a difference in our community and hospital. I feel so fortunate to be able to do my part in making a difference, by being part of the Board of Directors as Vice-Chair and as Fundraising Chair. I work with such amazing individuals and would like to thank everyone for their dedication, time and hard work, making the Clinton Public Hospital Foundation's fundraising efforts such a success!

Clinton Public Hospital Foundation Finance & Investment Annual Report 2019-2020

I am pleased to provide the following financial report to the Foundation for the year ending March 31, 2019.

We have received and reviewed the financial reports for 2019-2020 and this year was very successful. We can attribute our success in fundraising to Clinton Raceway's biennial Legends' Day, the annual CKNX Radiothon, the Christmas Campaign, third-party fundraising events, general donations and generous bequests.

The Foundation continues its mandate to provide substantial funds to the Clinton Public Hospital. For the 2019-2020 fiscal year, the Foundation transferred \$422,334.40, to the Clinton Public Hospital. This transfer allowed for the funding of various projects and equipment, including the renovations and installation of the digital x-ray unit, the inpatient accessible tub and shower room, a table and two bariatric chairs for the inpatient lounge (Auxiliary funded), a laryngoscope (Auxiliary funded), two CPR Training Mannequins and a pre-payment to the MDRD Refresh project. These funds also supported the recruitment of a new physician, nursing education and the PATH Project.

It has been my pleasure to fill the role of Treasurer for 2019-2020 and to have the support of this committee and the Board. I will continue as Treasurer for an additional year, with consent of the Board of Directors.

Clinton Public Hospital Foundation Medical Centre Annual Report 2019-2020

The Medical Centre building had several projects take place throughout the fiscal-year.

In November 2018, it was brought to the Foundation's attention that the wheelchair access button at the Medical Centre was not in an ideal location, making it difficult for patients to get out of the way of the door after pressing the button. The board agreed to relocate the access button to a post alongside the walkway. This project was completed in April of 2019.

It was discovered while changing a lightbulb in one of the pot lights at the clinic that the ballasts had begun to corrode. Eleven pot lights in the South Wing of the Medical Clinic building interior were determined to need replacement and this project was completed in July 2019.

In July 2019, during preparation for this year's accreditation process, it was identified that the clinic would require a renovation to accommodate clean and dirty utility rooms. One of the staff washrooms, with a separate shower area was reconfigured into both the clean and dirty utility rooms, meeting required specifications for the accreditation process. During the renovations, there was an issue with a water leak, which was repaired by the contractors at no cost to the Foundation. This project was completed in November 2019.

In October 2019, an issue with the sump pump in the basement was reported to the Foundation. Upon the contractor investigating, it was determined that it was actually an issue with the sewage pump and the pump was replaced.

It was presented to the Foundation in the fall, that consideration be made to have a designated contractor that can be hired by either the Clinton Family Health Team or the Foundation to complete small maintenance jobs at the clinic. Following a meeting in November with a local contractor and discussion about potential needs, a contractor was secured for these purposes.

In January 2020, the Clinton Family Health Team requested an additional garbage container for garbage pickup. These containers are charged to the Foundation's property tax bill by the municipality, at \$260 each per year. The Foundation is currently paying for two bins, so it was decided that the third bin would need to be charged to the Clinton Family Health Team. The Foundation will need to invoice the Clinton Family Health Team annually for this cost. The bin was ordered and delivered to the clinic.

In February 2020, it was reported that the South Pod of the Clinic was very cold. Upon investigation by HPHA facilities maintenance, it was discovered that the building requires an air system balancing. A contractor was contacted and the comfort air balancing scheduled for March 26, 2020. Due to the COVID-19 restrictions, the balancing was rescheduled for May and again due to continued restrictions, has been postponed until the fall of 2020.

Our revised lease agreement remains unchanged, after being reviewed with the Clinton Family Health Team, and signed thereafter on April 26, 2016.

I would like to thank Kim Van Wyk for her great assistance with any issues that arise at the Medical Centre. I would also like to thank the maintenance staff at Clinton Public Hospital for their assistance at the Medical Centre.

As part of the Foundation Coordinator responsibilities, Darlene continues to liaise with the Executive Director of the Medical Clinic and manage the Medical Clinic property, in collaboration with the Finance/Property Committee.
