Annual Report from the Chair 2020-2021

The 2020-2021 fiscal year was another very successful year for the Clinton Public Hospital Foundation, with thanks to our very generous community. In a year of uncertainty, with the ongoing COVID-19 pandemic restrictions, we were fortunate to have individuals, businesses and organizations who continued to support our mission through financial contributions.

Our biennial Gala was cancelled in 2020, due to restrictions on events. The "Bond Gala" had been designated to raise funds for the Medical Devices Reprocessing Department and Operating Room Refresh. Prior to it's cancellation, the Foundation had received funds for sponsorships and some ticket sales. Upon notifying sponsors and ticket holders of the cancellation, each of them asked that the Foundation keep their financial contribution as a donation in support of the project, which resulted in a net profit of \$38,736.87.

Moving forward, we made our CKNX Health Care Heroes Radiothon goal to raise funds for the MDRD/OR Refresh project. Letters were mailed to previous Gala attendees, sponsors and supporters, soliciting support towards the project through the Radiothon. The Radiothon was held virtually on Saturday, October 17th and raised \$67,089.14 towards the MDRD/OR Refresh. We have participated in the CKNX Health Care Heroes Radiothon since its inception in 2002 and throughout those years we have received donations for an accumulated total of \$613,173.26.

In conjunction with the Radiothon, the Clinton & District Kinsmen once again hosted their annual breakfast on Saturday, October 17, at the Central Huron Community Complex. This year the breakfast was offered as take-out only and was well supported. The generosity and dedication of the Clinton & District Kinsmen is greatly appreciated!

In December each year, we launch our annual Christmas Campaign. We send out a general letter giving thanks to our supportive community and sending them Season's Greetings. This year, students at Central Huron Secondary School were able to volunteer time to assist us with the campaign by stuffing the envelopes for us. It takes approximately 90 hours to stuff and sort the mailing, so it is very helpful to have the students' assistance with this and I thank them for doing this. The letters, along with donation forms, were mailed out to our local community on December 1st, which coincided with Giving Tuesday, as the kick off to the giving season. As in past years, we received many generous donations throughout the holiday season. This year the campaign was very successful and raised a net profit of \$43,787.07.

Throughout the 2020-2021 fiscal-year, we received multiple bequests (\$145,000.00) and many memorial donations (\$22,597.46). We are truly grateful to those who plan ahead to make a financial gift to the Clinton Public Hospital Foundation upon their passing and also to the families who name the Foundation as the charity to receive donations in memory of their loved one.

The Auxiliary to the Clinton Public Hospital were generous in transferring \$20,000 to the Foundation in 2020-2021 to be used for the purchase the ECG Machine, Trolley and Cart, along with two Single Channel IV Pumps. We are truly grateful to have the dedication and support of our Auxiliary.

In addition to our fundraising efforts, the Clinton Public Hospital Foundation Board of Directors and Staff have continued to share the Foundation's various activities on our website and on social media. The Foundation continues to focus on public communication and a social networking presence, as a means to keeping our community and donors informed.

With the financial support of our donors and through grant opportunities, we were able to transfer a total of \$1,009,410.12 in the 2020-2021 fiscal year. This transfer of funds supported the following projects and equipment purchases:

- Renovations and Equipment for the MDRD/OR Refresh
- Eye Trauma Slit Lamp (Emergency Department)

- ECG Machine, trolley and cart
- 15 Single Channel IV Pumps
- Portable Ultrasound Machine (Emergency Department)
- BMD Unit and Suite Renovations (Imaging Department)
- Microsoft Surfaces (Inpatient Unit)
- Charging Stations (Emergency Department & Inpatient Unit)
- 5 Isolation Towers through RBC Nursing Strategy Grant
- Negative Air Pressure Machine, Portable Pressure Monitor, Ante Room Panel Kit, iPad and Stand,
 Communication Station Protective Screens, Workstations on Wheels and Vital Signs Towers through the CMA Foundation Community Hospitals COVID-19 Fund

In 2020-2021, the Foundation recorded a total of 329.5 volunteer hours, which included 320 hours in director roles and 9.5 volunteer community hours. Volunteer hours accounted for 21% of the hours contributed to the Foundation, with the other 79% in staffing hours. Volunteers are an enormous asset to the Foundation. This year saw a decline in community volunteer hours, in great part due to the ongoing COVID-19 restrictions. I am truly grateful for the support of our volunteers and I look forward to a time that we can all work together again.

It has been a great year for the Foundation. I would like to thank each director for their hard work and commitment, allowing the Foundation to be successful in meeting our commitments to our hospital. I would also like to thank the CPH Auxiliary, the staff and the community for supporting the Foundation in our mission. On behalf of the Board of Directors, I would like to extend our heartfelt thanks to every individual, business and organization, who has supported the Clinton Public Hospital. We are very fortunate to be a part of such a caring community.

Clinton Public Hospital Foundation Fundraising Annual Report 2020-2021

It has been an interesting year for fundraising, as the COVID-19 pandemic has had a significant impact on our ability to host our traditional fundraising events. It continues to be apparent however, that we live in a very generous community, as people continue to support Clinton Public Hospital.

With plans well underway for the 2020 Biennial "Bond Gala", the event had to be cancelled in June 2020 and it was decided in September 2020 that we would not reschedule the event, but instead proceed with our next Gala in June 2022. Prior to the cancellation, we had already received \$39,082.88 from sponsorships and ticket sales. Those who had already sent payment requested that their contributions be kept as a donation towards the Medical Devices Reprocessing Department and Operating Room Refresh project.

The Foundation took part in the annual CKNX Health Care Heroes Radiothon again this year, which was held virtually on Saturday, October 17, 2020. We set our fundraising project to raise \$40,000 towards the MDRD/OR Refresh. Given that our Gala was not rescheduled, we mailed letters of request for support to previous Gala supporters, asking that they continue to support the MDRD/OR Project with a donation to this year's Radiothon. Through generous donations, we raised an astounding \$67,089.14, surpassing our goal. These funds were used towards the project, which has now been fully completed and the new Operating Room is now available for surgical procedures. As in past years, the Clinton & District Kinsmen hosted their annual breakfast on Saturday, October 17, at the Central Huron Community Complex. This year due to the restrictions, the breakfast was take-out only. The commitment and support of the Clinton & District Kinsmen is truly amazing. The Foundation has participated in the CKNX since its inception in 2002 and over those 15 years, we've received donations for an accumulated total of \$613,173.26 for our hospital.

This fiscal-year, two third-party fundraising events took place, contributing towards the success of our financial goals. In addition to these fundraising events, we received many other donations from individuals, organizations and businesses throughout the year. The Foundation was also the recipient of multiple grants in support of upgrades due to COVID-19. All donations large or small make a difference to our hospital, and we are appreciative of each contribution.

This year's Christmas Campaign was supported by individuals and businesses, from Clinton and surrounding communities. The campaign brought in a net profit of \$43,787.07 from these generous donations, which is significantly higher than our average profit from the campaign. At such a busy time of year, it is truly wonderful to see that the Christmas Spirit is still alive and well in our community. Words cannot express the appreciation that the Foundation has for the financial support during this wondrous time of year.

The Clinton Public Hospital Auxiliary continues to be a very hard working an amazing group of individuals and we sincerely thank them for their continued support. Each year, the Auxiliary presents the Foundation with a cheque from their fundraising efforts. In September 2020, again they presented us with a wonderful donation in the amount of \$20,000.00, to support the purchase of an ECG Machine with Cart and Trolley, along with two additional Single Channel IV Pumps.

I am so grateful to be able to volunteer and make a difference in our community and hospital. I feel so fortunate to be able to do my part in making a difference, by being part of the Board of Directors as Vice-Chair and as Fundraising Chair. I work with such amazing individuals and would like to thank everyone for their dedication, time and hard work, making the Clinton Public Hospital Foundation's fundraising efforts such a success!

Clinton Public Hospital Foundation Finance & Investment Annual Report 2020-2021

I am pleased to provide the following financial report to the Foundation for the year ending March 31, 2021.

We have received and reviewed the financial reports for 2020-2021 and this year was very successful. We can attribute our success in fundraising to the annual CKNX Radiothon, the Christmas Campaign, third-party fundraising events, general donations and generous bequests. Throughout the COVID-19 pandemic our community continues to support our hospital through financial contributions.

The Foundation continues its mandate to provide substantial funds to the Clinton Public Hospital. For the 2020-2021 fiscal year, the Foundation transferred \$1,009,410.12 to the Clinton Public Hospital. This transfer allowed for the funding of various projects and equipment, including renovations and equipment for the Medical Devices Reprocessing Department and Operating Room Refresh, an Eye Trauma Slit Lamp (Royal Canadian Legion Grant), ECG Machine with trolley and cart (Auxiliary Funded), 15 Single Channel IV Pumps (6 Auxiliary Funded), Portable Ultrasound Machine, BMD Unit and Suite renovations, Microsoft Surfaces, Charging Stations, 5 Isolation Towers (RBC Nursing Strategy Grant) and equipment in response to COVID-19 (CMA Foundation Community Hospitals COVID-19 Fund).

It has been my pleasure to fill the role of Treasurer for 2020-2021 and to have the support of this committee and the Board. I am happy to continue as Treasurer for an additional year, with consent of the Board of Directors.

Clinton Public Hospital Foundation Medical Centre Annual Report 2020-2021

This fiscal-year several small projects were completed at the Clinton Medical Clinic by an independent contractor. In addition, new lighting was installed in the parking lot at the clinic.

In February of 2020, it was reported that the South Pod of the Clinic was very cold. Upon investigation by HPHA facilities maintenance, it was discovered that the building requires an air system balancing. A contractor was contacted and the comfort air balancing scheduled for March 26, 2020. Due to the COVID-19 restrictions, the balancing has been postponed, with plans to reschedule for this fall.

With our lease agreement expiring May 31, 2021, we reviewed the lease with the Clinton Family Health Team and Physicians in April 2021. Following revisions, a new agreement was drafted, approved by the Clinton Public Hospital Foundation Board of Directors and signed on May 14, 2021. The new lease is for a term of five years from June 1, 2021 through May 31, 2026.

I would like to thank Kim Van Wyk for her great assistance with any issues that arise at the Medical Centre. I would also like to thank the maintenance staff at Clinton Public Hospital for their assistance at the Medical Centre.

As part of the Foundation Coordinator responsibilities, Darlene continues to liaise with the Executive Director of the Medical Clinic and manage the Medical Clinic property, in collaboration with the Finance/Property Committee.
